The prayer in this writ petition is to issue a Writ of Mandamus, directing the respondent to consider the representation dated 03.02.2026 and remove the illegal encroachment in Survey No.89/37 in Devar Street, Keela Managalakurichi Village, Thoothukudi District.

2. Learned Additional Government Pleader appearing for the respondents 1 to 6 would submit that the respondents 1 to 6 will conduct survey and if there is any encroachment in the abovesaid survey number as alleged by the petitioner, the same will be removed by due process of law within a time frame.

3. Recording the said submission, the respondents 1 to 6 are directed to conduct survey and ascertain as to whether there is any encroachment in Survey No.89/37, Devar Street, Keela Managalakurichi Village, Thoothukudi District, as alleged by the petitioner. If so, such encroachment shall be removed by due process of law after affording

opportunity to the private respondents and all other parties concerned.

Such an exercise shall be completed within a period of six weeks from the date of receipt of a copy of this order.
