ORDER

This Writ Petition has been filed to direct the Respondent to issue a separate patta to petitioner's name in respect of petitioner's agricultural land in Survey No.268/3C total extent 42 Ares (1 acre 4 cents) out of 50 cents in joint patta No.2165 situated at Vikkiramangalam Village, Usilampatti Taluk, Madurai District, based on petitioner's sale deed Doc.No.1694 of 2005 dated 15.11.2005 and petitioner's application No.2025/0105/24 dated 03.11.2025 within a specific period as fixed by this Court.

2. The learned counsel for the petitioner submitted that the petitioner purchased the property through a sale deed registered as Doc. No. 1694 of 2005, dated 15.11.2005. The petitioner subsequently filed an online application (No. 2025/0105/24) on 03.11.2025, after paying the requisite charges.
