ORDER

This Writ Petition has been filed to direct the second respondent to consider the petitioner's representation dated 22.01.2024 seeking allotment of monthly installment house constructed by the Tamil Nadu Urban Habitat Development Board Rajakoor, Madurai District.

2. The learned counsel appearing for the petitioner would submit that the petitioner is very poor, who is finding it difficult to meet her day-to-day necessities. The petitioner has no own house.
