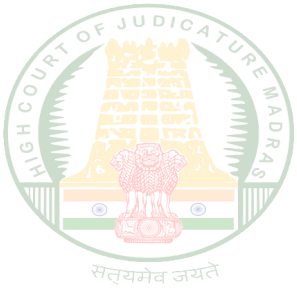
COMMON ORDER

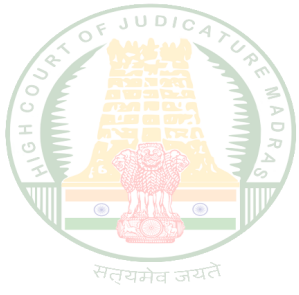
