2. The learned Government Advocate appearing for the respondents submitted that the petitioner is seeking rectification of a UDR error. He further

stated that the District Revenue Officer had taken up the petitioner's complaint and conducted an enquiry, which has since been completed. However, before an order could be passed, the Lok Sabha elections were announced, and therefore the respondents were unable to pass the order.
