ORDER

2. This Civil Revision Petition under Article 227 of the Constitution of India has been filed to expedite the disposal in O.S. No. 149 of 2022 on the file of the Subordinate Court, Devakottai (hereinafter referred to as 'the Trial Court' for short).

3. This Court, during earlier hearing on 24.04.2024, had passed the following order:-

“2. The Subordinate Court, Devakottai shall send a report as to whether there is any impediment for conducting further proceedings in O.S. No. 149 of 2022 and if so, shall explain the reasons for the same, before the next hearing.”

Having regard to the contents of the said report, there shall be a direction to the learned Subordinate Judge, Devakottai, to dispose of the Suit in O.S.No. 149 of 2022, as expeditiously as possible.
