ORDER

This petition has been filed by the petitioners seeking for suspension of sentence imposed on the petitioners in the judgment made in S.C.No.73 of 2020 on the file of the learned I Additional Principal District and Sessions Judge, Thoothukudi dated 05.11.2025 and to enlarge the petitioners on bail.
