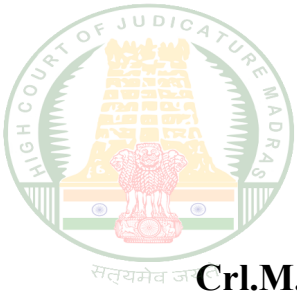

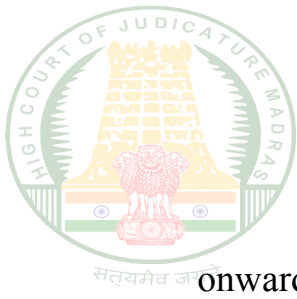

4. When this Court granted suspension of sentence, this Court imposed a condition to the effect that the petitioners will stay at Chengalpet and report before the Chengalpet Town Police Station daily at 10.30 a.m., and 05.30 p.m., until further orders. These petitions have been filed to modify / relax the said condition.

5. The learned Additional Public Prosecutor submitted that the petitioners have been complying with the condition from 19.01.2026
