ORDER

2. The learned counsel for the petitioner submitted that the petitioner has been complying with the conditions imposed by this Court and he prays for relaxation of the said condition.

3.The learned Government Advocate (Crl. Side), on instructions, submitted that the petitioner has been complying with the conditions from 20.02.2026. He further submitted that the investigation has already been completed and that the investigating agency will be filing the final report within a short span of time.
