It could be seen from the records that the fourth respondent has entered into sale agreement with the fifth respondent for purchasing the property and there is a dispute between the respondents 4 and 5. The petitioner has no connection whatsoever with the said transaction. Merely because, the fourth respondent is working as a maid servant in the house of the petitioner, the petitioner is being called for an enquiry.

3. Considering the above said facts, there shall be a direction to the respondent police not to call the petitioner for any further enquiry.
