ORDER

The present petition has been filed by the accused persons in C.C.No. 98 of 2024 on the file of the Additional District Munsif Cum Judicial Magistrate, Sivagiri seeking to quash the charge sheet wherein they are charged with the offences under Sections 296(b), 127(2), 115(2), 351(3) of Bharatiya Nyaya Sanhita (BNS), 2023 and Section 4 of Tamil Nadu Prohibition of Harassment of Women Act, 2002.
