ORDER

This petition has been filed by the petitioner seeking for suspension of the sentence imposed in the judgment passed by the III Additional District and Sessions Court, Tirunelveli made in S.C. No. 143 of 2021 dated 28.04.2025 and to enlarge the petitioner on bail.

2. Heard the learned counsel on either side.

3. This is the second petition filed by the petitioner seeking for suspension of sentence. The earlier petition filed in CrI.M.P.(MD).No. 7400 of 2025 came to be dismissed by an order dated 05.01.2026 as withdrawn. However, on going through the order, it is seen that the Court was not inclined to grant suspension of sentence and at that point of time, the petition was withdrawn. In view of the same, the same has to be construed as dismissed on merits.
