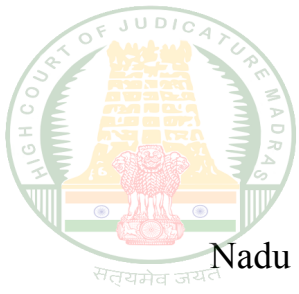

Nadu Government Servants (Conditions of Service) Act, 2016 and consequently to direct the respondents to consider the petitioner for appointment to the post of B.T. Assistant / BRTE under BC Category on the basis of marks secured by him, within the stipulated time fixed by this Court.

2. This matter earlier came up for consideration before this Court on 26.03.2026 and the same was adjourned for filing counter.

Today, when the matter is listed again, Mr.Amjad Khan, learned Standing Counsel appearing for third responded brought to the notice of this Court that the third respondent has already published the reserve list on 04.06.2026 and also placed before this Court a copy of Notification No. 3/2023 dated 25.10.2023, Addendum Notification No.03A/2023 dated 15.11.2023, Addendum Notification No.03B/2023 dated 17.05.2024.

4. In the light of the above, the main relief sought in the writ petition is already redressed. Accordingly, this writ petition is disposed
