ORDER

This Writ Appeal is filed challenging the order passed by the learned single Judge in W.P(MD)No.31337 of 2024.

2.The learned counsel appearing for the respondents states that subsequent to the filing of the present writ appeal, the first and second respondents filed a review application. In the review application, the learned single Judge has recalled the earlier order dated 20.12.2024 and dismissed the W.P(MD)No.31337 of 2024 vide order dated 18.12.2024. Therefore, he submits that nothing survives for adjudication in the present writ appeal.
