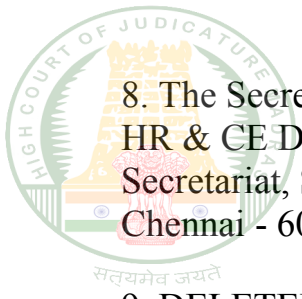

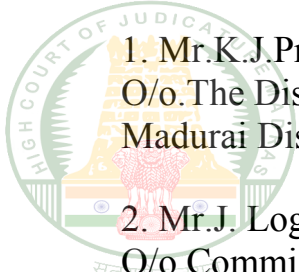
2. Hence, this petition is allowed. Registry is directed to number the writ appeal if the papers are otherwise in order and list the appeal along with connected batch of appeals.
