The prayer in this writ petition is to issue a Writ of Mandamus, directing the 2<sup>nd</sup> respondent to remove the encroachment made by the 6<sup>th</sup> respondent in the Government land in T.S.No.147, Block No.12, Deputy Collector Colony, Madurai North Taluk, Madurai District, based on the representation dated 06.11.2025 within a time frame.

2. Today, when the writ petition was taken up for hearing,

learned Additional Government Pleader appearing for the respondents 1, 3 and 5, on instructions, would submit that the Tahsildar has already called for a report from the Town Surveyor on 11.02.2026 with regard to the alleged encroachment.

3. In that view of the matter, let the 3<sup>rd</sup> respondent/Tahsildar take appropriate action as per law after giving notice to all the parties concerned, provided, the subject land is Government land. The said exercise shall be completed within a period of four weeks from the date of receipt of a copy of this order.

4. With the above direction, the Writ Petition is disposed of.
