In the said circumstances, this writ petition is allowed and the respondents are directed to pay interest to the petitioner at the rate of 6% per annum for the payment of gratuity, provident fund EL surrender salary, leave salary and pension commutation, from the date of his retirement till the date on which the terminal benefits are paid to the petitioner. The respondents are further directed to comply with the said direction as expeditiously as possible, at any rate, within a period of twelve weeks from the date of receipt of a copy of this order. No costs.
