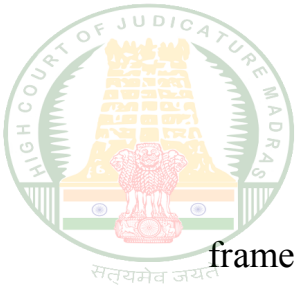

J.Suseela, W/o.Jayaraman. The deceased had subscribed to the said scheme and she died on 26.10.2025.

2. The petitioner claims to be the son of the deceased insured and he made a representation with the respondents to disburse the said insurance amount. The petitioner's grievance is that the said representation has not been considered as of today.

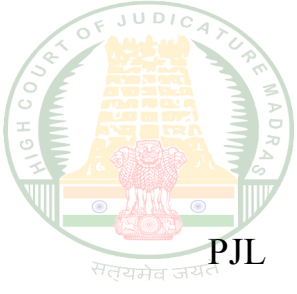
6. The said exercises shall be completed within a period of six(6) weeks from the date of receipt of a copy of this order.
