The proceedings, which are the subject matter of this writ petition, are now admittedly pending before the Tribunal for Disciplinary Proceedings since the year 2023 and about three years have already elapsed. The grievance of the petitioner is that because of the prolonged disciplinary proceedings, his further prospectus in the service are seriously prejudiced.

5. Mr.S.Shaji Bino, learned Special Government Pleader, appearing for the respondent, on instructions, submitted that the proceedings
