PETITION FOR ANTICIPATORY BAIL Under Sec.482 of BNSS

PRAYER :-

For Anticipatory Bail in Cr.No. 60 of 2026 on the file of the
respondent police.

The petitioner, who apprehends arrest at the hands of the respondent for the offences punishable under Sections 333, 296(b), 309(4), 311, 351(3) of BNS, 2023 in Crime No. 60 of 2026 on the file of the respondent police, seeks anticipatory bail.

2. The case of the prosecution is that on 09.03.2026 at about 7.00 p.m., the petitioner and other accused trespassed into the shop of the defacto complainant, abused him in filthy language and robbed a sum of Rs.7000/- and assaulted and threatened him with dire consequences. Hence, the case.

3. The learned counsel for the petitioner would submit that the petitioner is innocent and he was falsely implicated in this case and he is no way connected in the above said incident. He has not committed any offence as alleged by the prosecution. He would further submit that co-accused was released on bail by the Trial Court. Hence, he prayed to grant Anticipatory Bail to the petitioner.

4. The learned Government Advocate (Crl. Side) would submit that based on the complaint given by the defacto complainant, a case has been registered for the offences punishable under Sections 333, 296(b), 309(4), 311, 351(3) of BNS, 2023 in Crime No. 60 of 2026. He would further submit that the petitioner has nine previous cases, which are not similar in nature. He would further submit that the investigation is pending and the offences are grave in nature and hence, he opposed to grant anticipatory bail to the petitioner.

5. Heard both sides and perused the materials available on record.

6. Considering the rival submissions made on either side and the nature of offences charged against the petitioner, and considering the facts that co-accused was released on bail, though the petitioner has nine previous cases, the same are not similar in nature and in all cases, the petitioner was granted bail, I am inclined to grant anticipatory bail to the petitioner, subject to the following conditions:

[a] Accordingly, the petitioner is ordered to be released

on anticipatory bail on condition to execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate-II, Sattur, Virudhunagar, and on further conditions that:

[b] the petitioner shall report before the Inspector of Police, Sankarankovil Police Station, Tenkasi, daily at 10.30 a.m., until further orders;

[c] the petitioner shall not commit any offences of similar nature.

[d] the petitioner shall not abscond either during investigation or trial.

[e] the petitioner shall not tamper with evidence or witness either during investigation or trial.

[f] On breach of any of the aforesaid conditions, the learned Judicial Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself
