In view of the above, the petitioner company is directed to forthwith give all the necessary details of misappropriation made by the erstwhile Manager to the second respondent police and on receipt of the same, the second respondent police is directed to re-open the enquiry and conclude the investigation within a period of 3 weeks, thereafter.
