When the matter came up for hearing, the learned Additional Public Prosecutor, on instructions, submitted that already an enquiry was conducted by the respondent police, where the petitioner as well as the respondents 7 and 8 had given a written undertaking that they will resolve their disputes before the competent civil Court, based on which, despite CSR is issued, the said complaint was closed.

5. In view of the submission made by the learned Additional Public Prosecutor, directing the petitioner and the respondents 7 and 8 to resolve their dispute by approaching the competent civil forum, this Writ Petition is disposed of.
