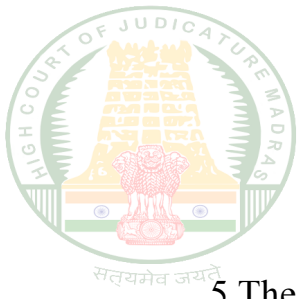

survey number has been classified as “hospital”. The respondents have issued notice under Section 7 of the Tamil Nadu Land Encroachment Act.

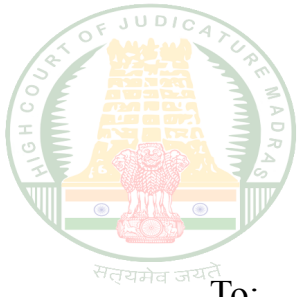

If that be so, the petitioner has to challenge the same in the manner known to law.
