5. The learned counsel appearing for the petitioner submitted that the order was served on the petitioner only on 24.03.2026. Be that as it may, it was contended that the delay pertains solely to the lapse of time, and it was further represented that, if the petitioner submits a fresh application, the same would be considered.

6. In view thereof, the writ petition is disposed of on the following terms:-

- i. Within one week from the date of receipt of a web copy of the order, without waiting for the certified copy of the order, the petitioner shall make a fresh application and the same shall be considered and permission shall be granted to the petitioner to apply the minibus in accordance with law as per the permit that is already granted.
- ii. The said exercise shall be completed within a period of four weeks therefrom.
- iii. No costs. Consequently, W.P(MD).Nos.9213 and 9214 of 2026 stands disposed of.
