In the light of the above, without going into the merits of the matters, these writ petitions are disposed of directing the petitioners to submit their explanations in response to the charge memos within a period of four weeks from today. On receipt of the explanations submitted by the petitioners, the fourth respondent shall conclude the disciplinary proceedings within a period of three months from the date of receipt of explanations submitted by the petitioners. No costs. Consequently, connected miscellaneous petitions are closed.
