The learned counsel appearing for the petitioner informs the Court that the matter has become infructuous.

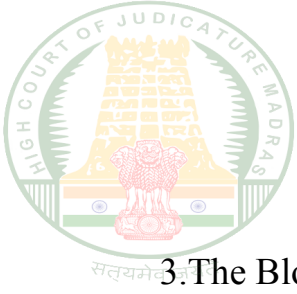
