PRAYER:-Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of MANDAMUS directing the Respondents to pay interest at the rate of 12 percent per annum, for the period of delay from the petitioners date of retirement (30.04.2025) to till the date of reimbursement (11.03.2026) of amount paid towards the petitioners terminal and pension benefits namely EPF Employees Contribution, Gratuity, Encashment of Earned/Sick Leave and other monetary benefits within a time frame as may be fixed by this Honble Court, without affecting the petitioners right to claim balance amounts towards those benefits.

In the said circumstances, this writ petition is allowed and the respondents are directed to pay interest at the rate of 6% per annum for the belated payment of the petitioner's terminal benefits, including EPF Employee's Contribution, Gratuity Encashment of Earned/Sick Leave and other monetary benefits from the date of his retirement till the date on which the terminal benefits are paid to the petitioner. The respondents are further directed to comply with the said direction as expeditiously as possible, at any rate, within a period of twelve weeks from the date of receipt of a copy of this order. No costs.
