The short ground raised by the petitioner in this writ petition is that the second respondent has imposed a punishment of dismissal from service vide order dated 08.05.2023 and aggrieved by the same, the petitioner claims to have filed a statutory appeal before the first respondent under Regulation 17 of Central Bank of India Officers' (Discipline and Appeal) Regulation, 1976, as early as on 28.06.2023. But the said appeal is still pending and no action has been taken by the first respondent. Hence, the petitioner approached this Court by filing the present writ petition seeking for expeditious disposal of the said appeal dated 28.06.2023.

4. Mr. N.Dilip Kumar, learned Standing Counsel appearing for the respondents fairly submitted that the appeal filed by the petitioner would be considered and disposed of within a period of eight weeks from today.

5. In the light of the above, without going into the merits of the matter, this writ petition is disposed of at the admissions stage directing the first respondent to dispose of the appeal dated 28.06.2023 filed by the petitioner against the proceedings bearing No. Zo/DEL/HCM/DAD/2023-2123 dated 18.05.2023 as expeditiously as
