2. The learned counsel for the petitioner submitted that the petitioner is seeking the grant of a Natham Patta on the basis of long-standing occupation of the land, and accordingly requests issuance of the patta.

3. The learned Government Advocate appearing for the respondents submitted that although the petitioner is in occupation of more than 9 cents of land, under the Natham scheme, the petitioner is entitled to only 2.75 cents.

4. Considering the facts and circumstances of the case, this Court directs the respondents to consider the petitioner's representation dated 14.03.2026 and pass appropriate orders in accordance with law, within a period of 12 weeks from the date of receipt of a copy of this order.

5. With these directions, this Writ Petition is disposed of. No costs.
