3. With the above direction, this Civil Revision Petition is disposed of. There shall be no order as to costs.

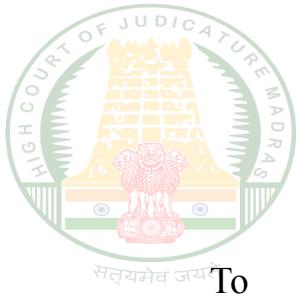
