The present Contempt Petition has been filed alleging violation of the order of this Court dated 22.09.2025 made in W.P.(MD).No.25144 of 2025.

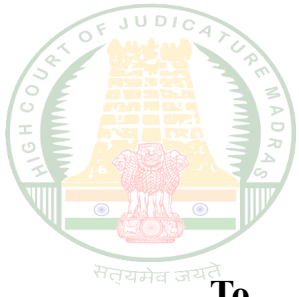
