ORDER

The petitioner has approached this Court seeking issuance of a Writ of Mandamus directing the respondents to transfer her to an existing post at Rajapalayam/Town/East, Virudhunagar District, or to the Veerasigamani Section, Tirunelveli District, by considering her representation dated 16.03.2026, with reference to the proceedings of the second respondent in Memo.No. 1000011961 / 006077/ G.49/G.492/ 2025-15, dated 05.03.2026.

WEB COPY 2. The petitioner was serving as an Assessor in the respondent Board/Corporation at Tirunelveli. She was promoted to the post of Inspector of Assessment and, by proceedings dated 05.03.2026, was posted to Coimbatore District.

3. Considering that Coimbatore District is located at a distance of more than 300 kilometres from her previous place of posting, the petitioner submitted a representation dated 16.03.2026 requesting for posting her at Virudhunagar District in an existing vacancy at Rajapalayam/Town/East or at the Veerasigamani Section in Tirunelveli District. As no response was received to the said representation, the petitioner has approached this Court by filing the present writ petition.

4. Mr. B. Ramanathan, learned Standing Counsel appearing for the respondents, submitted that if any such request for reposting is pending, the same will be duly considered by the respondents.
