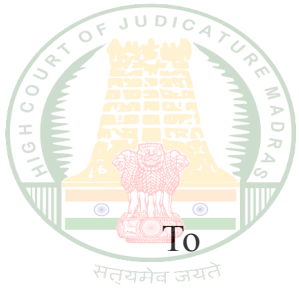
3.Recording the above submission, these review applications are closed.
