ORDER

This writ petition has been filed seeking issuance of a writ of mandamus, directing the second respondent to update the petitioner's details in Survey No. 830/4 in Lakshmipuram Village, Kalkulam Taluk, Kanniyakumari District extend of 30 cents based on the petitioner's representation dated on 08.11.2018 and 11.11.2022.

2. Heard the learned counsel for the parties.

The petitioner submitted a representation dated 11.11.2022 to the respondents to update the petitioner's details in Survey No. 830/4 in Lakshmipuram Village, Kalkulam Taluk, Kanniyakumari District, in respect of the properties referred to above. However, no action has been taken on the said representation. Hence, the present writ petition has been filed.

4. Learned Government Advocate, appearing on behalf of the respondents, submits that the petitioner's representation would be considered on merits and in accordance with law.

6. The representation shall be considered and disposed of after conducting an inquiry. The second respondent is further directed to afford a reasonable opportunity to the petitioner and to all other persons who may be affected by such decision during the course of the inquiry. There shall be no order as to costs.
