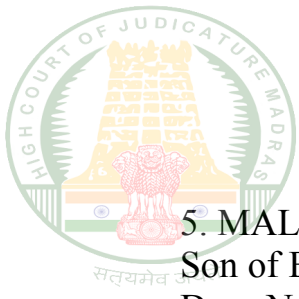

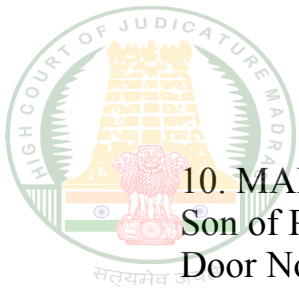

This petition has been filed to implead the proposed fourth respondent as the fourth respondent in the main Writ Petition.

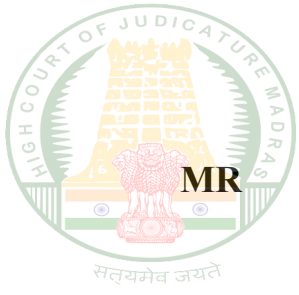
2.Learned Special Government Pleader appearing for the respondents has no objection.
