PRAYER: Petition filed under Article 226 of the Constitution of India, to issue a writ of mandamus directing the respondents to pay the petitioner interest at the rate of 18% per annum for the period of delay from 01.08.2025 to 10.03.2026 in paying the amounts paid towards his terminal benefits, namely, EPF employee's contribution, gratuity, encashment of leaves and commutated value of pension, within a time frame as may be fixed by this Court, without affecting his right to claim balance amounts towards those benefits.

In the said circumstances, this writ petition is allowed and the respondents are directed to pay interest at the rate of 6% per annum for the belated payment of the petitioner's terminal benefits, namely, EPF employee's contribution, gratuity, encashment of leaves and commutated value of pension, from the date of his retirement till the date on which those benefits are paid to the petitioner. The respondents are further directed to comply with the said direction as expeditiously as possible, at any rate, within a period of five months from the date of receipt of a copy of this order. No costs.
