PETITION FOR ANTICIPATORY BAIL Under Sec.482
of BNSS

PRAYER :- For Anticipatory Bail in Cr.No. 129
of 2026 on the file of the respondent police.



ORDER : The Court made the following order :-

The petitioner/A2, who apprehends arrest at the hands of the respondent for the offences punishable under Sections 191(2), 191(3), 296(b), 115(2), 118(1) and 351(2) of BNS, 2023, and Section 4 of TNPHW Act, in Crime No.129 of 2026 on the file of the respondent police, seeks anticipatory bail.

2. The case of the prosecution is that on 12.03.2026 at about 09.15 p.m., while the defacto complainant stand outside his house, A1's dog attempted to bite him. When the same was questioned by the defacto complainant, the petitioner and other accused persons entered into the defacto complainant's house and abused him in filthy language and also attacked him. Hence, the case.

WEB COPY 3. The learned counsel for the petitioner would submit that the petitioner is an innocent person and he was falsely implicated in this case and he is no way connected in the above said incident. Hence, he prays to grant anticipatory bail to the petitioner.

4. The learned Government Advocate (Crl. Side) fairly submits that the petitioner has no previous cases and the injured person has been discharged from the hospital. He would further submit that the investigation is pending and the offence are grave in nature. Hence, he opposes to grant anticipatory bail to the petitioner.

5. Heard both sides and perused the materials available on record.

6. Considering the rival submissions on

either side and the nature of offences charged against the petitioner and there was a dispute between the parties regarding the dog biting and the injured person has been discharged from the hospital and the material part of the investigation might have been completed and also considering the fact that the petitioner has no previous cases, I am inclined to grant anticipatory bail to the petitioner, subject to the following conditions:

[a] Accordingly, the petitioner is ordered to be released on anticipatory bail on condition to execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate No.VI, Madurai, and on further conditions that:

[b] the petitioner shall appear

before the respondent Police once in a week ie., on Every Saturday at 10.30 a.m., for a period of four weeks and thereafter, as and when required for interrogation.

[c] the petitioner shall not commit any offences of similar nature.

[d] the petitioner shall not abscond either during investigation or trial.

[e] the petitioner shall not tamper with evidence or witness either during investigation or trial.

[f] On breach of any of the aforesaid conditions, the learned Judicial Magistrate/Trial Court is entitled to take appropriate action against the

petitioner in accordance with law as if the conditions have been imposed and the petitioners released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560].

[g] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 B.N.S.
