PRAYER:- Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of MANDAMUS directing the respondents to pay the petitioner interest at the rate of 18 percent per annum, for the period of delay from 01.06.25 to 10.03.26, in paying the amounts paid towards his terminal and pension benefits namely EPF Employees Contribution, Gratuity, Encashment of Leaves/Already Surrendered Earned Leaves within a time frame as may be fixed by this Court and without affecting his right to claim balance amounts towards those benefits and thus render justice.

Earned/Sick Leave and other monetary benefits from the date of his retirement till the date on which the terminal benefits are paid to the petitioner.
