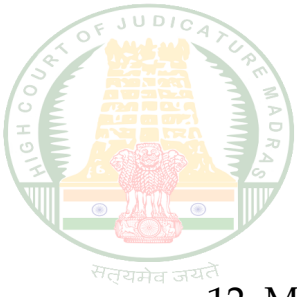

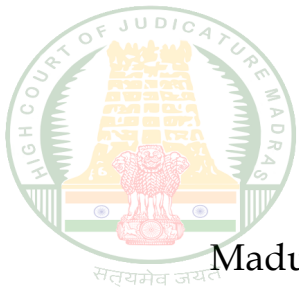

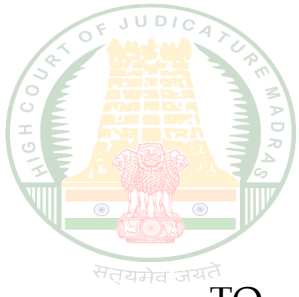
- *the petitioners shall appear before the respondent police daily at 10.30 a.m. until further orders;*
