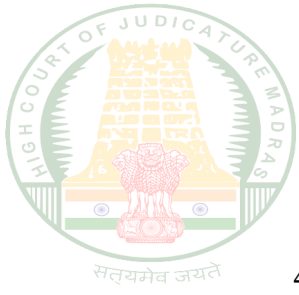
ORDER

This petition has been filed by the petitioner seeking for suspension of sentence imposed by the learned Sessions Judge, Fast Track Mahila Court, Srivilliputhur, Virudhunagar District in S.C. No. 57 of 2020 dated 18.09.2024 and to enlarge the petitioner on bail.

2. Heard the learned counsel on either side.

3. This is the second petition filed by the petitioner seeking for suspension of sentence. The earlier petition filed in CrI.M.P.(MD).No. 18202 of 2025 came to be dismissed by an order dated 06.01.2026 as withdrawn. However, on going through the order, it is seen that the Court was not inclined to grant suspension of sentence and at that point of time, the petition was withdrawn. In view of the same, the same has to be construed as dismissed on merits.
