In view of the above, this Court, without going into the merits of the claim made by the petitioner, directs the sixth respondent to dispose of the representations made by the petitioner dated 13.03.2026 and 24.03.2026 and pass appropriate orders on merits and in accordance with law, after affording due opportunity of personal hearing to the petitioner. Such exercise shall be completed within a period of three months from the date of receipt of a copy of this order.
