2.The petitioner has approached this Court seeking issuance of a Writ of Mandamus directing the respondents to consider the

3.In the said representation, the petitioner sought allotment of a door number and assessment of the dwelling house constructed in Survey No. 268/1A situated at Gopalamudram Village, Cheranmahadevi Taluk, Tirunelveli District. The grievance of the petitioner is that, despite receipt of the said representation, the respondents have not acceded to the petitioner's request.

4.Mr. P. Subbaraj, learned Special Government Pleader appearing for the sixth respondent, on instructions, submitted that the petitioner's representation dated 24.03.2026 would be considered on merits by the sixth respondent within the time frame fixed by this Court. The said submission is taken on record.

5.In view of the above, the writ petition stands disposed of with a direction to the sixth respondent to consider the petitioner's representation dated 24.03.2026 on its own merits and pass appropriate orders in accordance with law.
