3. With the above said observations, this Criminal Original Petition stands allowed.

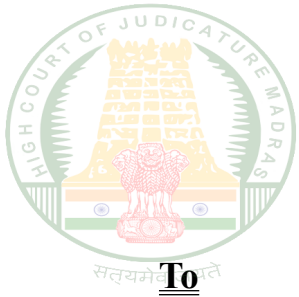
