ORDER : The Court made the following order :-



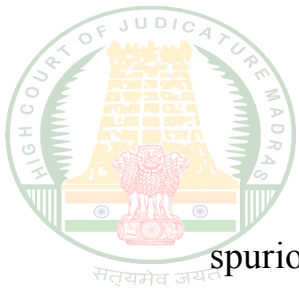

The petitioner, who apprehends arrest at the hands of the respondent for the offences punishable under Sections 316(2) and 318(4) of BNS, 2023, in Crime No.320 of 2025 on the file of the respondent police, seeks anticipatory bail.

2. The case of the prosecution is that the defacto complainant is running a gold loan finance business in the name of “Shanmuga Gold Finance”. The petitioner received a sum of Rs.12,70,000/- by pledging the spurious jewels on various occasions and various dates. Hence, the case.

3. The learned counsel for the petitioner would submit that the petitioner is an innocent and he was falsely implicated in this case and he has no way connected in the above said incident. He would further submit that the petitioner's name was not found in the FIR and already the co-accused were arrested and released on bail and no previous case is pending against the petitioner. Hence, he prays to grant anticipatory bail to the petitioner.

4. The learned Government Advocate (Crl. Side) would submit that the petitioner received a sum of Rs.12,70,000/- by pledging the

spurious jewels in the defacto complainant's finance company and the investigation is still pending. Hence, he opposes to grant anticipatory bail to the petitioner. He would further submit that the co-accused were arrested and released on bail and no previous case is pending against the petitioner.

5. Heard both sides and perused the materials available on record.

6. Considering the rival submissions on either side and the nature of offences charged against the petitioner, and the petitioner is not a named accused in the FIR and already the co-accused were arrested and released on bail and no previous case is pending against the petitioner, I am inclined to grant anticipatory bail to the petitioner, subject to the following conditions:

[a] Accordingly, the petitioner is ordered to be released on bail in the event of arrest or on his appearance, within a period of fifteen days from the date on which the order copy made ready, before the learned **Judicial Magistrate No.II, Karur**, on condition that the petitioner

shall execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate concerned and on further conditions that:

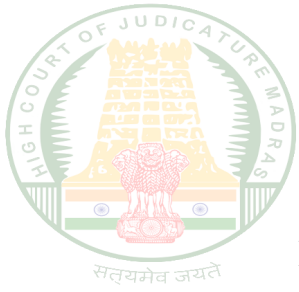
[b] the petitioner shall report before the respondent police, daily at 10.30 a.m. for a period of 30 days, and thereafter as and when required for the interrogation.

[c] the petitioner shall not commit any offences of similar nature.

[d] the petitioner shall not abscond either during investigation or trial.

[e] the petitioner shall not tamper with evidence or witness either during investigation or trial.

[f] On breach of any of the aforesaid conditions, the learned Judicial Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in

[g] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 B.N.S.
