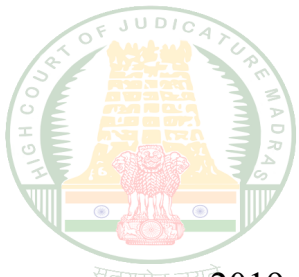

2019, dated 28.02.2025, convicting the petitioner to twelve months similar imprisonment in default of payment of Rs.3,20,000/- as maintenance, this criminal revision case is filed.

However, so far only an amount of Rs. 1,50,000/- has been paid and the petitioner had not come forward to settle the balance arrears of maintenance. The Inspector of Police, Taluk Police Station, Palani is directed to secure the petitioner to custody executing the order passed by the learned trial Court.
