It is the case of the petitioner that the petitioner is the owner of the property and that the third respondent / Executive Officer is attempting to hand over the petitioner's patta land to the Pedestrains' Association. Aggrieved over the same, the petitioner submitted a representation to the respondents on 02.05.2023. Since the said representation has not been considered till date, the petitioner has approached this Court.

3. The learned Government Advocate appearing for respondent Nos.1, 2 and 4 would submit that the representation of the petitioner dated 02.05.2023 would be considered in accordance with law.

4. In view of the same, without expressing any opinion on the merits of the matter, this Court directs the respondents to consider the representation of the petitioner dated 02.05.2023 and pass appropriate orders on merits and in accordance with law, within a period of eight weeks from the date of receipt of a copy of this order.
