It is admitted that the private respondents are enjoying a civil Court's decree in their favour. The writ petitioner is said to have filed a second appeal before this Court; however, the same is still pending at the SR stage in S.A(MD)SR No. 15945 of 2019. When the private respondents are armed with a civil Court's decree, obviously the State authorities cannot act any breach thereof.
