2. The petitioner's claim was already considered by the Village Administrative Officer and the Deputy Collector for Land Acquisition and they have recommended to the 2<sup>nd</sup> respondent to rectify the error in the UDR. However, the 2<sup>nd</sup> respondent has not passed any orders.

Therefore, the 2<sup>nd</sup> respondent is directed to consider the petitioner's representation dated 20.12.2025 in the light of the recommendation made by the Village Administrative Officer and the Deputy Collector for Land Acquisition and pass appropriate orders in accordance with law, within a period of eight weeks from the date of receipt of a copy of this order.

4. With the above direction, the Writ Petition is disposed of. No costs.
