The learned counsel appearing for the petitioner would submit that the petitioners were granted bail by the learned Principal Sessions Judge, Sivagangai with a condition to report before the respondent police daily at 10.00a.m., for a period of 30 days. He would further submit that the due to ill health the petitioners were unable to comply with the conditions and further the respondent police also threatened the petitioners, thereby the present petition has been filed to modify the condition.

3. The learned Government Advocate(Crl.Side) appearing for the petitioners would submit that the petitioner have complied with the condition only for 10 days and thereby he objected to modify the condition imposed by this Court.
