Prayer:

ORDER

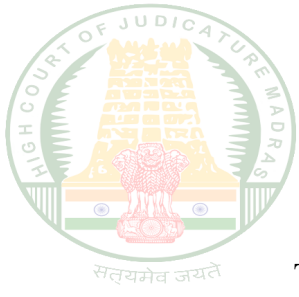
(Order of the Court was made by the Hon'ble N.Anand Venkatesh J.)

This petition has been filed to modify one of the condition that was imposed by this Court to the effect that out of the two sureties one of the surety shall be the blood relative.

3. Considering the grounds raised in this petition, the condition No.9 (i) imposed by this Court in CrI.M.P.(MD).No.5838 of 2026 dated 15.04.2026 is modified as follows:

The petitioner is directed to be enlarged on bail on executing a bond for Rs.25,000/- (Rupees Twenty Five thousand only) with two sureties, each for a like sum to the satisfaction of the Special Court for trial of Cases under SC/ST (POA) Act, Theni District.
